

WEEK 12: REDBIRDS RULE THE ROOST

After 12 weeks of play, the **Redbirds** of Tirebiter have reclaimed the roost by cranking out a weekly total of 556.4 points for Week 12, second-best among the Brotherhood, while former pace car driver PAwesome saw his **Wahoos** put up the second-lowest point total for the week with 424.2 points, just ahead of the last-place **Blues** (391.0). By outscoring the **Wahoos** by more than 140 points for the week, the **Redbirds** went from trailing the **Wahoos** by about 70 points to leading them by 72.1 points. There figures to be a lot more bouncing around between 1st and 2nd by these two teams before this season is in the books.

Also in the news, Blow Top's team finally had a breakout week and led all teams with 629.3 points for the 12th week. Clearly this team is getting some help from outside the organization, and some anonymous owners are calling for a full investigation. Rumors abound that there are some for-profit services out there who, for the right price, will provide tips and alerts about such things like upcoming player callups from the minors, and it is just this sort of professional "service" that has long been considered taboo in our league, at least by gentlemen's agreement if not formally.

Be that as it may--for now--the **Chiefs** have used this Week 12 "bounce" to rocket all the way up to 9th place, past the **Bombers** and just behind the **Tribe**, **Tigers** and **Monarchs**.

The **Skipjacks** continue their surge with a Week 12 total of 544.1 points, fourth best in the league, allowing them to creep ever closer to the **Senators**. Whether this Itchie *magic* can prevail over the course of the season, well that remains to be seen.

INDIVIDUAL PERFORMANCES

On the pitching side of the equation, Trevor Bauer of the **Bums** has regained his form and led the league with a blistering total of 67.0 points for Week 12. Chris Sale of the **Chiefs** continued his torrid month of June with 63.0 points in Week 12. The suddenly pitching rich **Bums** also claimed the third-highest individual pitching total for the week-twice--with his iron Mikes (Leake and Minor) both notching an impressive 51.0 points for the week. Add to that Justin Verlander's 33.0 points for the week in a single start, and the **Bums** had four pitchers in the top 17 for the week, and between the four of them they totaled 202.0 points for the week. If this league really is all about pitching, you really do have to like the **Bums**' chances in the balance of the campaign. At the opposite end of the spectrum, Sunny's recent pickup, Nick Margevicius, got beat around badly last week, walking the **Blues** backwards to the hurtful tune of -23 points. Youch. That hurts.

On the hitting side of the ledger, the **Jax'** Charlie Blackmon had a monster point total of 92.1 (best ever?) for the week, and JT's Ketel Marte had the second highest total for the week with 62.7 points. Wow.

AND THE BEAT GOES ON

There was much lively discourse on this 2019 HSL junket about the memorable¹ van drive on our 1992 junket from Detroit to Toronto to Cleveland and back to Detroit again, wherein B.T. made the executive decision to veer our van onto the *right*² shoulder to pass hundreds if not thousands of vehicles³ in order to get us to a baseball game in time. The debate has been raging, on and off, for the past year or thereabouts. It was reignited during our drive down to Arlington in B.T.'s luxury mobile outhouse, when yours truly reported to Big Guy that he (me) had clear and convincing⁴ evidence that the Van Shoulder Episode occurred during the Toronto to Cleveland leg of the Trip, *and not* while en route from Detroit to Toronto, as postured by the never-say-wrong Big Guy. - ✓ Itchie's dusting in Cleveland.

It is assumed that we can all stipulate that memories of 1992 were much better in the year 2000 than they are now. And it is assumed that it can further be stipulated that no member of the Hot Stove League at that time in 2000 (11 of you, as Screech was not in the league at that time) objected in any way to this recounting of the event or offered a correction; not in writing, not verbally, nor otherwise. In the eyes of the law, this is known as *acquiescence* or *tacit assent*.


For the 25-year HSL anniversary Trip to New York in 2009, league owners were asked to submit their top memories from Trips past. Cleveland

Opposing Evidence

Called upon to present any evidence that he might have in support of the opposing view (i.e., that the Van Shoulder Episode occurred during the Detroit to Toronto leg of the Trip), Barrister Drews proffered the bawdacious statement that he "remembers" that our flight into Detroit arrived in the afternoon and therefore did not leave us a great deal of time to get to Toronto for that night's game, and that we had to go directly to the game instead of checking into our hotel because we were delayed by an "accident". In the words of Jackie Chiles, this is unprecedented. Unsubstantiated. Unbelievable. Nonsensical. Unacceptable. Preposterous.

While Big Guy's so-called evidence would survive neither a *Daubert* motion nor a motion for a directed verdict, let's just suppose, hypothetically, that he could find a sympathetic jurist's ear which would allow him to proceed forward with his house-of-cards case.

Road projects on the road to anywhere

There are plenty of resurfacing and bridge projects on the road to anywhere in Ohio this spring and summer.

In the Cleveland area, there will be work on some Interstate 71 bridges and on the Interstate 90 bridge over the Rocky River. Repaying will take place on I-90 west of Cleveland near Bay Village and east of the downtown from Ohio 283 east to Wickliffe. Most work should be done by the end of June.

A particular headache, according to Michelle Rafferty of the Ohio Department of Transportation, may be bridge work on I-90 at Babbitt Road, East 260th, East 222nd and Lakewood Boulevard. Those projects could add incentive to take the Interstate-271 bypass around Cleveland on the way to Buffalo and Canada.

For drivers headed south on I-71, a major repaying project is under way below Columbus between Ohio 56 in Madison County and Ohio 41 in Fayette County. The 10-mile long job won't be done until mid-November.

For the last two summers, Columbus has been a no-man's land for interstate drivers. While conditions will be better this summer, some work is planned, according to Ms. Rafferty.

Work on widening a bridge will reduce I-71 to two lanes of traffic each way between I-270 and Polaris Parkway on the city's far north side.

Traffic on the I-270 bypass will be restricted in early spring east of the High Street exit for bridge painting.

Drivers headed east for Wheeling on Interstate 270 will run into construction between Hamilton Road and Interstate 70 starting in August.

Inside Columbus, I-70 has three construction projects already under way between Third Street and Cleveland Avenue, between Cleveland Avenue and I-71 and between I-71 and Ohio 315. Traffic will be maintained and work should be done by fall.

Drivers going west on I-70 toward Indiana will run into a long resurfacing project in Clark County near Springfield that will narrow the traffic lanes.

Going east on I-70 toward Wheeling, major work on the interstate will begin in July in Zanesville.

And so, ladies and gentlemen of the jury, you have all of the evidence that you need to dispense of this trifling matter in a New York minute, because it has been proven not by




A LIFE WELL LIVED



Dr. Henry Thompson Lynch January 4, 1928 - June 2, 2019

On Monday last I went to the memorial service for Dr. Henry Thompson Lynch, whose passing was mentioned in a recent issue of *From the Bullpen*. The memorial celebration was held at St. John's Cathedral on the Creighton campus, where Henry was reportedly a frequent visitor.

The beautiful and immense cathedral was packed with family, friends, patients, colleagues, collaborators and caregivers, a staggering number of attendees given Henry's age of 91 when he passed.

A proud Irishman, the service began and ended with the singing of "Oh Danny Boy," which perfectly set the tone for the service. Tears. Between the words of the chief celebrant, Father James Clifton, S.J., who knew Henry for almost thirty years, and the primary non-clerical eulogist, the Dean of the Creighton University Medical School, Dr. Robert W. Dunlay, who knew Henry very well for a long number of years, a few of the stories and comments worth passing along are as follows:


- Dr. Lynch was the chairman of Creighton University's Department of Preventive Medicine for *more than fifty years*, the chair of the department for more than half a century. Try to wrap your head around that.
- After his beloved wife Jane, the mother of their three children and his chief research collaborator for the lion's share of their 60+ year-old marriage, passed away seven years ago, Dr. Lynch was in personal despair. After a series of significant medical issues reduced him to being on a kidney machine to stay alive for a prolonged period of time, his personal physician and good friend told him that his God, his family, and his friends would all understand if he decided that it was time to stop

the "extraordinary measure" of remaining on a kidney machine, and that if he wanted to be removed from it so that he could peacefully pass on and join his wife Jane in the hereafter, Dr. Dunlay would gladly write the medical order for it. Henry's response, according to Dr. Dunlay, was, "Don't even think about it, Bob. I've got way too much work yet to do." Amazing. And indeed, he worked for three or four more years after that episode, publishing several new articles on hereditary cancer and lecturing at several different symposiums.

- When he first began writing and lecturing about his work on hereditary cancer thirty or forty years ago, espousing the concept that some cancers may be inherited and therefore potentially preventable, his views were considered *heretical*. He was reportedly scorned and ridiculed by many of his colleagues who were so-called experts in the field. Only through his tenacity while researching familial cancers by painstakingly and methodically constructing family pedigrees and tirelessly researching the subject was he able to eventually change minds. One speaker said that "Good Scientists Expand Our Knowledge," but that "Great Scientists Change the Way We Look at Things."
- Dr. Dunlay remarked that Henry had the unique ability to connect with and communicate to his patients some very complicated medical information and concepts, which he said was "a gift not possessed by many brilliant scientists."
- Father Clifton talked about the Henry Lynch Symposium that was hosted by Creighton University in 2015, in which many esteemed scientists came to Omaha from all around the globe at their own expense, likening the event to a Beatles Reunion.
- Dr. Dunlay said that recently he sat down with Dr. Lynch and they agreed that because Dr. Lynch was not "immortal," they would need to lay the groundwork for a succession plan, to which Henry readily agreed. However, even as part of the transition, just last year Dr. Lynch laid out his own "ten-year plan" of research, so it is clear that he did not intend to be rushed into the transition of retirement.


• Father Clifton told us that in all of his interactions with Dr. Lynch, Henry was unbelievably referential to him and to the other priests at Creighton University, and that possibly he was one of the most self-effacing and humble men that he had ever met. He called him a "man of great faith, piety and humility," who saw no conflict between his science and his faith. Beautiful words about a beautiful human being. A true hero.

BOOK REPORT: PATH TO POWER By Robert A. Caro Random House 1981




I recently finished the first volume of Robert Caro's eventual four tome masterpiece on the life of Lyndon Baines Johnson, our 36th president. The first volume, entitled *The Years of Lyndon Johnson: The Path to Power*, is probably the most meticulously researched book I have ever read. Caro and his wife--both New Yorkers--moved to the hill country of Texas (west of Austin) for three years so that they could gain the trust of and get to know the poor, plain folk who lived in the town (Johnson City) and area where LBJ lived his formative years. They then moved to Washington, D.C. for four years for research on LBJ's early experiences there, first as a congressman's secretary, and then as a young congressman.

The book details in mesmerizing fashion the rags-to-riches-to-rags lives of LBJ's forebearers, including his grandfather Samuel Ealy Johnson Sr. and his father Samuel Jr., and how the failures of his father and grandfather fueled LBJ's fierce ambition and drive to succeed. From a very young age, LBJ set his sights on nothing less than the highest office of the United States, and worked tirelessly and ruthlessly to ascend the treacherous climb to the presidency.



In a very detailed and factual way--without an ounce of salaciousness, and without sounding judgmental or inclined toward criticism--Caro makes a very convincing case that Johnson was a frequent, almost pathological liar, unlike any president we have seen since Richard Milhous Nixon.¹⁴ In addition, he was calculating, scheming, manipu-



lative and mendacious. As a husband to Lady Bird, he was demanding and dominant, as well as disloyal. In spite of his ungainly features (huge ears and nose) and his oft-displayed vulgarity, women were drawn to his power, and he was a well-known womanizer throughout his marriage to Bird.

At 762 pages, the book is a commitment and somewhat intimidating to start, but once one is through the introduction, it is a highly readable page-turner that does an amazing job of holding the reader's attention.



Caro previously won the Pulitzer Prize for his treasured biography about Robert Moses, *The Power Broker*. I haven't read that book yet, but if it's anything like *The Path to Power*, it is a must-read, along with the remaining tomes about LBJ: *The Means of Ascent* (1990); *The Master of the Senate* (2002); and *The Passage of Power* (2012).

As I mentioned to a couple of you on the Trip, *The Path to Power* may be the best book I've ever read. If any of you want to borrow my copy, let me know and I would be happy to oblige.
